BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF

\$2,295

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral, e.g., cemetery, crematory, vault companies and others required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utilities expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory costs, recordkeeping, secretarial, and administrative expenses.

This fee for our basic services and overhead will be added to the total cost of funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains.)

EMBALMING

\$ 895

Except in certain cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

IMMEDIATE BURIAL \$2,915 to \$13,385

The charge for immediate burial includes basic services of staff, local removal of remains, local transportation to the cemetery and necessary authorizations. This charge does not include the use of facilities for any visitation or ceremony prior to burial nor does it include embalming, grave opening or any grave equipment.

DIRECT CREMATION \$3,320 to \$8,030

The charge for direct cremation includes basic services of staff, local removal of remains, transportation to crematory, other preparation, refrigeration and the crematory charge, and the State cremation fee. This charge does not include the use of facilities for any visitation or ceremony prior to cremation nor does it include embalming, grave opening or any grave equipment. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the deceased and can be made of materials like fiberboard or composite materials (with or without an outside covering). The containers we provide are a fiberboard container or an unfinished wood box.
